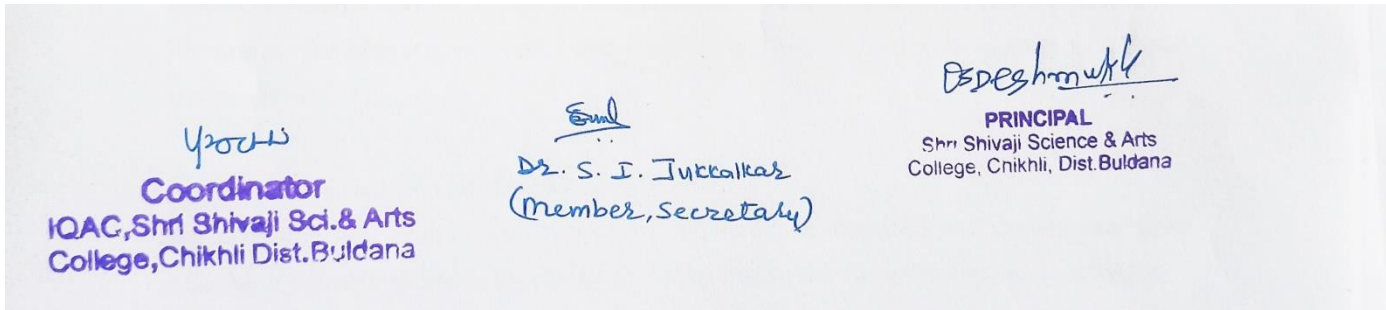

Discussion : The Principal discussed the names of the members and the responsibility they have to carry of the Minority Cell. All agreed to the formation of the committee.

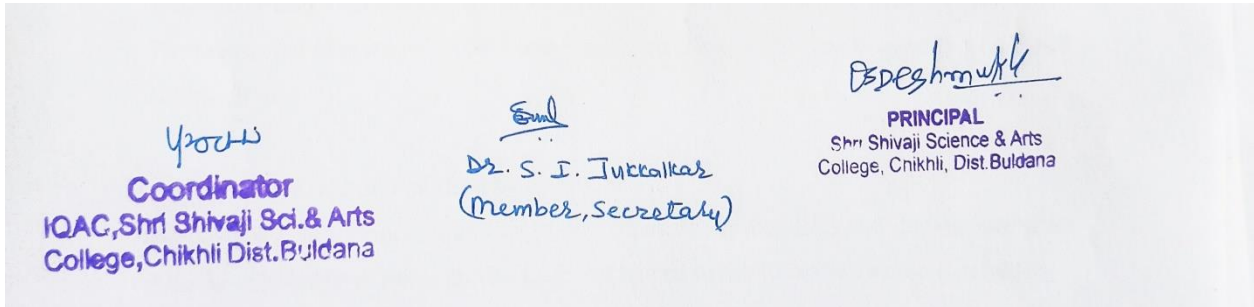
Agenda 2: Introducing Minority Students with government scholarships
