






Action Taken Report

- 4) An urgent meeting of the Examination Grievance Committee under the Chairmanship of the Principal was called on 24/08/2021. The plan of action to solve the examination related problems was discussed and finalized. Work to be done was assigned to the In-Charge and other committee members.
- 5) Notice was displayed on Notice Board and forwarded to all students' WhatsApp Group to give written application regarding their grievances of university examination and results with all relevant documents.
- 6) After collection of applications, the committee took review of the grievances and the grievances were submitted to the university examination centre.
