a) Alternative Sources and Energy

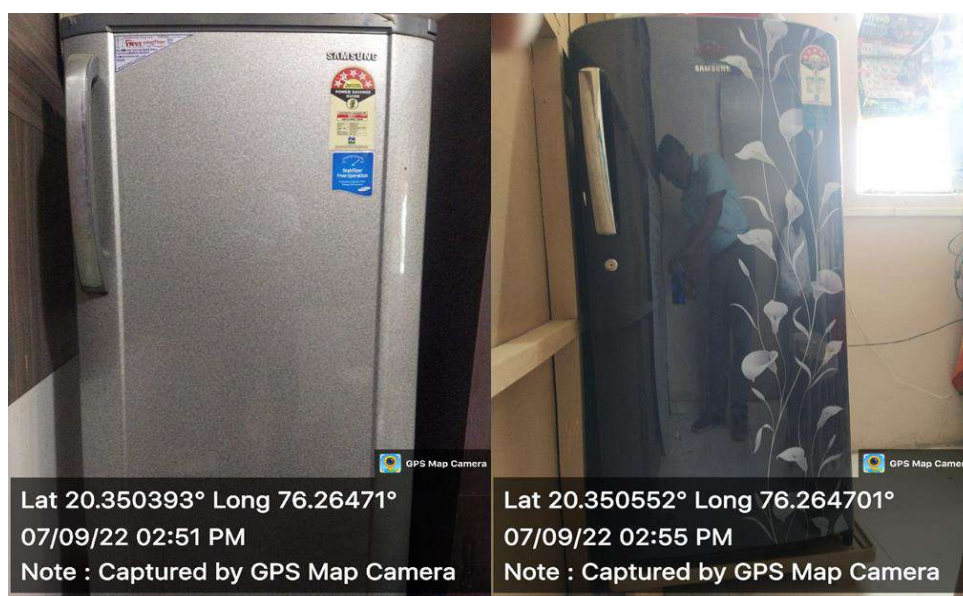

- High energy efficient equipments (four star & five star rated equipments) such as refrigerators are available in Microbiology and Zoology.
- Installation of 15kW on grid solar plant is in process

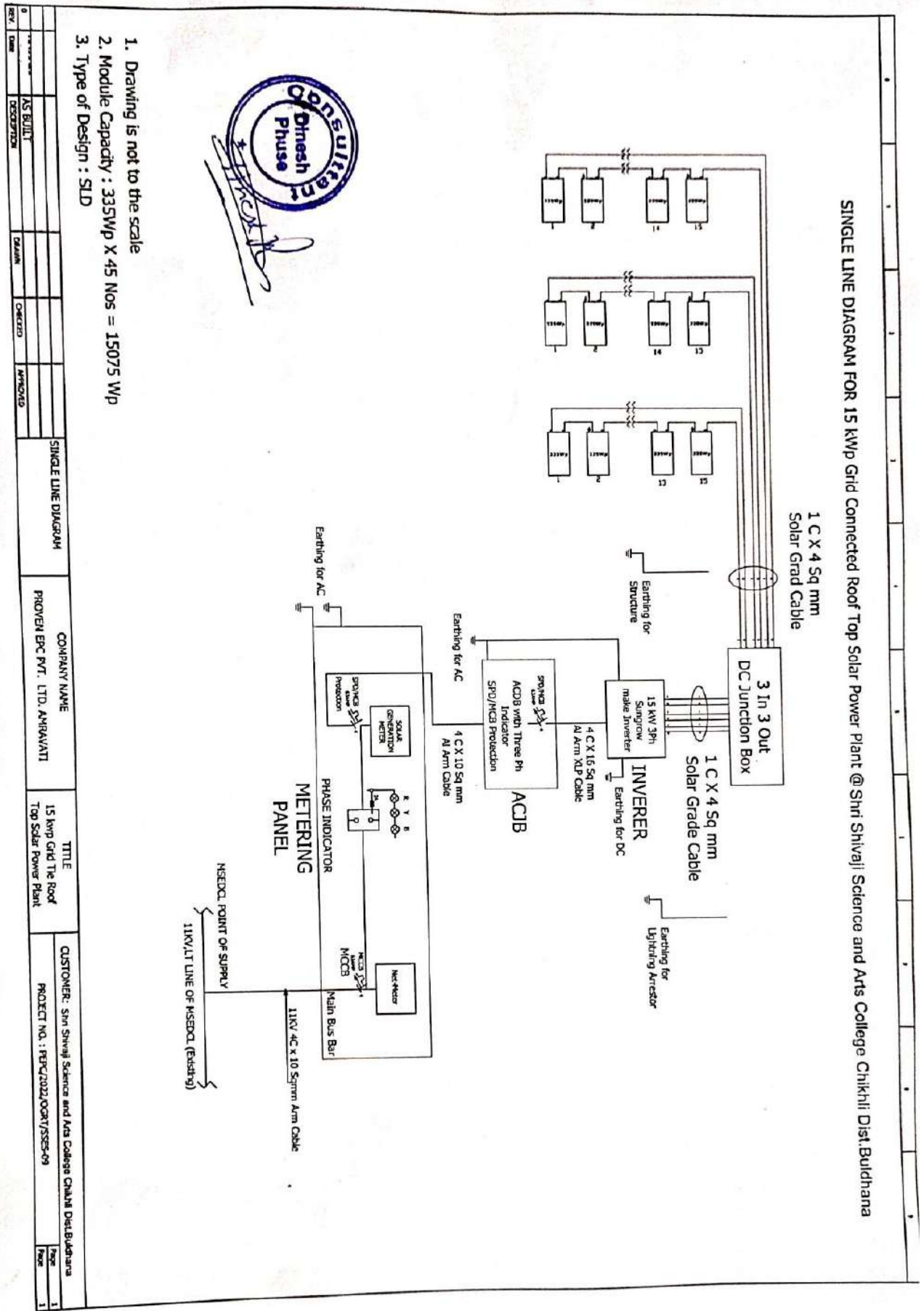

2) Management Of the Various Types of Degradable and Nondegradable Waste:

To minimize the production of waste on the campus institute has framed a policy document. It is a guidance document to the faculty, staff and students to behave responsibly in the production of waste, waste segregation, storage, handling, transport and disposal. Institute manages solid, liquid and E-waste. Notices about Ban on single use plastic, save energy tips and minimum use of paper were circulated among all stakeholders. Moreover, display boards, suggestion plates were used to create awareness at distinct places and in laboratories

a) In House Vermi-Compost Project:

To implement the concept of green and clean campus Vermicomposting project is implemented here. Recycled organic manure from the all types of biodegradable waste is to be produced.

The organic biodegradable waste is mixed with cow-dung in the ratio of 1:8. Beds of it are prepared & showered with water. On these beds the earthworm species E-foetida is spread. It is estimated that about 5000 worms can produce 01 Ton of organic manure within a month. Cleanliness drive being organised to collect solid organic waste in the campus by NSS & NCC students.

b) Solid Waste Management & Certificate from Municipal Corporation Chikhli:

To keep campus, keep clean, neat and tidy, Dustbins are placed in the college premises, corridors and office. The Institute has proper waste disposal mechanism. The solid waste is segregated into organic and is used to prepare compost for in-house consumption and non-degradable waste is collected by the Municipal Corporation Chikhli. Cleanliness drive being organised to collect solid waste in the campus by NSS & NCC students.







c) **E-Waste Management & Certificate from Municipal Corporation Chikhli:**



For this purpose, a catchment area is identified. The recharge zones of aquifers also identified and integrated water harvesting development activities are implemented with proper planning and management. Energy audit has been done by PPS Energy Solutions Private Limited, Pune, a government recognized private agency and Department of Physics. The Energy Efficiency Assessment was undertaken in order to evaluate energy performance and identify potential energy conservation measures. Environment and Green Audit has been done Nature Conservation Society, Akola (Maharashtra), a government recognized private agency and Department of Botany and Zoology. The methodology included data collection, insight inspection, evaluation, computation, conducting physical survey and review of relevant documentation. Tree plantation drive, cleanliness drive, seed ball preparation work, guest lectures on environmental issues, other eco-friendly activities also implemented in campus for green campus initiatives.

A brief report has been submitted to provide a high-level overview of the status of clean and green environment at college campus combined with an illustration of areas for further improvements.

- A. Department of Physics , Shri Shivaji Science and Arts College, Chikhli, Dist-Buldana, Pincode- 443201 (M.S.); the college established in 1967, and run by Shri Shivaji Education Society , Amravati, providing education in undergraduate, post graduate and PhD the area of Science , Arts and Commerce. 7. Neither this MoU, nor any activities described herein, shall be construed as creating a partnership, joint venture or other such relationship. Both parties agree that this MoU represents a nonexclusive relationship between the parties and nothing contained herein shall preclude either party from participating/initiating similar relationship with third parties.
8. This MoU may not be amended without the prior written consent of both the parties.
9. **Termination:** Either party can cancel or terminate this Agreement unilaterally (and without reason), by giving an advance written notice of one month to the other.
10. **Indemnity:** Each of the parties shall defend, indemnify and hold the other party harmless from and against any claim, liability, loss, costs or expenses (including reasonable Attorney’s fees) arising out of or resulting from the material breach of the provisions herein.


Article 5



- Provision for enquiry and information is made available at the entrance of the library.
- Disabled students are provided scribe at the exam center & extra time to write answer paper by the college for the university and college examinations as per university rules.
- Comfortable sitting arrangement is made for disables by the Officer In-Charge of the University Examination.
- College provides Reserved Quota & Scholarships for Divyangjan as per government rules.

Admission Procedure

Admission procedure will start immediately after the declaration of results of SSC, HSC and University exams.

The college has established an Admission Committee for the guidance of students.

Member of the committee will be available for their help during the prescribed time. Students should contact the committee members.

How to Apply

- Students desirous of taking admission to the college are required to obtain the prescribed application form along with prospectus.
- Students must fill in the complete application form carefully, clearly and legibly in his/her own handwriting. Please fill in all details. Incomplete form or form with false information will not be accepted.
- Signature of the Parent/Guardian on the form is mandatory.
- The documents must accompany the prescribed form. A check list is given along with application form.

(N.B.-Before submitting the original certificates in the college office, students are advised to take out sufficient number of Photostat copies of their documents for their convenience)

Rules and Instruction for Admission

- The admission in 11th Science /Arts/ Commerce & B. A. I., B. Sc. I, & B. Com. I and M.Com. I, M.A.I & M.Sc. I will be strictly on the merit basis.
- In all the other classes the eligible students will get direct admission.
- The number of students per class is fixed as per the Govt. rules, so the deserved candidates must take admission as early as possible.
- The Govt. & University rules and regulations are strictly followed to decide the number of students, reservation quota, eligibility, admission fees & the documents to be attached.
- Candidates expecting admission in 11th standard must compulsorily attach school leaving certificate, original mark sheet, and true-copies of the both (two copies each) along with the admission form for verification.
- A candidate who passed the qualifying exam from any other Board/University & desirous to seek admission should submit an eligibility certificate.
- Admission will be provisional subject to the approval of the University /Education Department and is liable to be cancelled at any time if the applicant has given false information.
- For university nomination the student of B. A. I, B. Sc. I and B. Com. I and M.Com. I, M.A. I & M. Sc. I must submit the original mark sheet (of all attempts) & true copies (2 copies each) along with the admission form for verification.

Subject:- Facilities, exemption and concession for differently abled and Physically disabled examinee of Sant Gadge Baba Amravati University examinations.

Whereas, the Ordinance No.6 and Ordinance No.18/2001 are in existence in respect of providing facilities and concessions for physically disabled students.

And

Whereas, the Government of Maharashtra Department of Higher and Technical Education had issued G.R. dated 4th of March, 2017 in respect of facilities exemptions for physically disabled students.

And

Whereas, the Management Council in its meeting held on 2-6-2018 vide item No.86 has accepted the afore mentioned G.R. along with the report of committee appointed by Hon'ble Vice-Chancellor and directed to issue direction in this regard.

And

Whereas, the directions No.32/2018 dated 26/6/2018, 43/2018 dated 26/12/2018 and 13/2019 dated 27/6/2019 could not be converted into relative legislation in terms of ordinance in a stipulated period in view of the provision of 12 (8) of Maharashtra Public Universities Act-2016.Hence, these directions are lapsed.

And

Whereas, the Academic Council in its meeting held on 13/1/2020 vide item No.4 has directed "Hereinafter, a fresh Direction shall be issued by superseding earlier Direction if the relative legislation not be made in stipulated period."

And

Whereas, the above said provisions are to be regulated by amending respective ordinances.

And

Whereas, aforesaid provisions are to be implemented from the Academic session 2020-21.

And

Whereas, the making amendments to concerned ordinance is time consuming process,

Now, therefore I, Dr. Murlidhar Chandekar, Vice-Chancellor, Sant Gadge Baba Amravati University, Amravati in exercise of powers conferred upon me under Sub-section (8) of Section 12 of the Maharashtra Public Universities Act-2016 do hereby direct as under-

- 1) This Direction may be called, " **Facilities, exemption and concession for differently abled and Physically disabled examinee of Sant Gadge Baba Amravati University examinations.**"

- 2) This Direction shall come in force with effect from the date of its issuance.
- 3) The following shall be the provisions for providing facilities, exemptions, concession for physically disabled students.
 - i) Principal of the respective affiliated college should prepare 'Disabled friends group' of minimum 10 friends out of which disabled students will select one of them who is willing to act as a writer for him/her .He can also select writer of his/her own choice
 - ii) Examination center will be the same college or nearer college to his/her house.
 - iii) Answer Books will be stamped as PWD and the necessary separate arrangements be made for evaluation.
 - iv) Differently abled students of all categories will be given additional 20 minutes per hour beside the stipulated time span.
 - v) Marks should not be deducted for any types of grammatical or technical mistakes at the time of evaluation.
 - vi) Attendance is not mandatory for appearing in the university examinations.
 - vii) All other facilities are applicable as per this direction and guidelines given in the Maharashtra Government Resolution miscellaneous no.2016 No.302 dated 4th of March,2017.
 - viii) This direction provides 3% grace marks of the total marks (aggregate) in one subject for "Head passing written examination, oral/viva, practical, research project etc." or by divisions to the rest of the followings heads.
 - a) Fixed the 3% marks of the total(aggregate).
 - b) Add marks to the subject with least or minimum marks obtained, first and thereafter, second, third, fourth and so on to the subjects in order of lower marks till the 3% of marks.
 - c) If needed , the marks as per the earlier ordinances (1/1985 and 18/2001) shall be awarded to the disabled candidates.
